Chief Shivers reported that Chief Galanski has been active on the TED Committee. Two of the three EVMS proposals were approved for 2024 FRI; AFFF PFAS Transition and Apparatus Purchasing and Specifications Writing.

Chief Rice reported that Cummins continues to work on its EPA CARB 2027 strategy. Cummins plans to launch the X10 and next gen X15 motors on January 1, 2026. The EPA regulations are highly challenging; however, Cummins understands the needs of the fire service and are working with all chassis builders to release the options that are important to the industry. Cummins will continue to work with FAMA and all agencies to minimize the impact on the fire service.

Chief Rice stated that Cummins expressed appreciation for the collaboration with the IAFC, FAMA and other industry association to ensure the fire service can complete the fire service mission.
