Chief Rice provided a briefing on the status of Cummins X10 and X15 motor development. The new prototype engines are now pushed out to at least January 2027 for them to be available in the market. This information was provided by the apparatus manufacturers who are hearing from Cummins representatives. There is no public release information from Cummins on the status of the engine release.
