Greg Rogers Kudos to Peg Paul on the new Sprinkler Education and the strategy to collaborate with developers on the importance of sprinklers – focus on the "Cost of not Sprinklering," a new tool kit for AHJs

FLSS Board Meeting

Peg Paul – HFSC received an FPNS grant, and we are now focusing on the strategy of using developer incentives to prevent sprinklers from being omitted from the codes when the codes are being updated. So suddenly, the developers are paying attention. The work that was done in Las Vegas is an excellent example of that. Thousands of homes have been sprinkled since that requirement, but we are developing a tool. We're putting this together that AHJ fire officials can use when preparing to go into a code meeting, where instead of constantly defending the cost of sprinkling, it's the cost of not sprinkling. We're stealing that from Todd Short, who recently retired from Redmond, WA, who often.

Every quarter, there was a report like that on all sprinkler buildings and all properties—the fire sprinkler coalition in residential. Instead, we are focusing on it. Here is what it costs the community when you do not sprinkler, and anytime you omit sprinklers from the codes, you are setting yourselves up for, you know, the opposite of community risk reduction.

And, of course, substandard homes.

So that is where we are going. Using this new grant to do that in a big part of the grant also puts that message through advertising in front of policymakers and elected officials.

The building community and then H JS let them know about this new material that we are developing.
